TOURNAMENT RULES

TEAM CAPTAIN: ENTRY CLOSING DATE IS FEBRUARY 7, 2013. MAIL ENTRY TO: OCUSBC, 13896 HARBOR BLVD. #5-A, GARDEN GROVE, CALIF. 92843. TELEPHONE (714-554-0111)

1. **FEES:** Remit ONE check, money order or certified check for the total fees. Make payable to OCUSBC. Personal checks are accepted. Fees must be remitted to cover the events listed. Entry fee is \$20.00 per bowler, per event. (Fees are not refunded once the schedule and prize list are prepared). There will be a \$15.00 fee for all returned checks.
2. **OPTIONAL ALL EVENTS:** The fee of \$5.00 in this event to be paid with the tournament entry fee. The ALL EVENTS will be transferred if substitute replaces one bowler in all three events.
3. **ELIGIBILITY:** Each entrant **MUST** be a member of the OCUSBC with a 21 game or more average bowled in an OCUSBC certified league. Members will be allowed to enter multiple times in TEAM event as long as not more than two players compete together more than once. Those entering doubles must also enter singles and vice-versa. You may only bowl doubles and singles one time.
 - a. **Not more than TWO professional bowlers on a TEAM line up.**
 - b. **Not more than ONE professional bowler on a DOUBLES line up.**
4. **AVERAGE:** Average must be established in one Orange County certified league. Use the average in the order given below.
 - a. **Highest OCUSBC book average of 2011-12.** (April 15, 2012)
 - b. **2012 Summer League Final Average:** Sweepstakes sheet must accompany entry.
 - c. **Winter League Average:** (Current Season 2012-13) Highest known average for the total number of games bowled as of Jan. 1, 2013.
 - d. If none of the above, the bowler will enter at 230.

NOTE: USBC Rule 319-c (re-rating) may be enforced at Tourn. Director's discretion
USBC Rule 319(a)(1), 319(a)(2), 319d and 319e will be waived
USBC Rule 319(a)(3) will be enforced (Failure to report correct average)
USBC Rule 202 applies (sport average adjustment)

5. **HANDICAP:** Bowlers will receive 90% of 230 for each event, including All Events.
6. **SUBSTITUTES:** Substitute(s) will be allowed in each event. Substitute(s) take the position of the original bowler with no change in line up.
7. **SCHEDULE INFORMATION:** Entries will be given preferences on date in the order in which they are received. When all squads are filled, the next available date will be assigned. Teams wishing to bowl together must submit entries together.
Group reservations may be made, but **FULL** payment of entry fees **MUST** be submitted no later than 2 weeks after reservations are made or the spots will be forfeited.

Bowlers will bowl doubles first. If one bowler is late for the doubles event, the entrant present will bowl singles event first. Late bowlers must start their game in the frame in which the other bowlers are at that time. Bowler(s) will not be permitted to make up missed frames.

In the event of a tie for 1st place, co-champions will be declared. The prize fund is returned 100% in a ratio of one prize for every 8 entries.

8. **BOWLING ATTIRE:** The following articles of clothing will not be permitted: Tank tops, halter tops, bicycle shorts or pants, cut-off jeans. Participants are requested to wear garments in good taste and appropriate for tournament bowling.
9. **DISQUALIFICATIONS:** While participating in scheduled events, a bowler may be disqualified immediately for the following:
 - (1) An infraction of the rules
 - (2) Conduct derogatory to the best interest of the tournament
 - (3) Being under the influence of liquor or drugs
 - (4) Use of a foreign substance(s)
 - (5) Use of a false average
 - (6) Failure to comply with the dress code

10. **PROTEST:** Any protest affecting eligibility or playing rules must be confirmed in writing to the tournament chairman within 14 days following close of tournament.
