We further agree that in the event of circumstances beyond the control of the Tournament Committee shall arise before or during the scheduled tournament, thereby causing a cancellation, postponement, or suspension, in part or in its entirety, the Tournament Committee shall not be held liable for the payment of cash prizes or other prize winning awards. Entrants having already bowled will be refunded the portion of the fee allocated to the prize fund. Entrants not having bowled will be refunded the prize fund and bowling fees. 1. **Eligibility:** All entrants must be members of Orange County USBC Association with a verifiable Orange County USBC average to be eligible to participate.
  - a. Participants are required to show their current USBC membership card (or receipt from league of card purchase) at time of check-in. Entrants failing to present current membership will receive a verification form which must be returned to the OCUSBC office no later than ten (10) days following participation in the tournament. Failure to return the verification form within the designated time shall result in the disqualification of the bowler's scores.
  - b. Any person who bowls under an assumed name, under the name of another person scheduled to bowl in the tournament, or who is under suspension from USBC membership shall be disqualified. The individual shall forfeit his/her entry fee, all prize monies, and be subject to suspension from USBC membership.
2. **Entry Fee:** \$30.00 per person (Lineage \$14.00 Expense \$2.00 Prize Fund 14.00)
  - a. Remit ONE personal check, money order or certified check for the total fees. Make payable to OCUSBC. Fees must be remitted to cover the events listed.
  - b. Credit cards are now accepted by calling the OCUSBC office.
  - c. You may bowl as many times as you wish but a bowler can only place once in his or her division for championship and only cash once in the prize fund.
  - d. The prize fund is returned 100% at least of one prize for every eight entries.
3. **Tournament Format:** Four (4) game singles handicap by division tournament, certified by USBC.
  - a. Any group wishing to bowl together please send entry forms in together in the same envelope or check-in together.
  - b. Handicap to be 90% of 220
  - c. Participants must be age 50 as of July 28, 2018
  - d. There will be a Men and Women division are based on age.

- e. Winners in each division will qualify to receive free entry into the 2018 CUSBC Senior Tournament. Entry fees must be paid by the bowler to CALUSBC and will be reimburse to the entrant upon proof of participation (copy of tournament recap will suffice)
4. **Average:** Entering average must be established in an Orange County certified league. The highest of the following averages will be used in the following order:
  - a. OCUSBC winter/summer average from 2016-17 season with a minimum of 21 games.
  - b. OCUSBC Winter average 2017-18 season with a minimum of 21 games
  - c. Current 2017-18 Summer - League sheet must accompany entry.
  - d. If none of the above, the bowler will enter at 220.

**USBC Rule 319c (re-rating) will be enforced as necessary**

**USBC Rules 319d and 319e will be waived**

**USBC Rule 319a (3) will be enforced (failure to report correct average)**

**USBC Rule 201 applies (sport average adjustment) and will be enforced as necessary**

**Any bowler who bowls in a 'challenge' league, or any other known league that bowls on a sport condition, which does not certify with USBC as a sport league, will be subject to re-rating by the Tournament Director as deemed necessary by the OCUSBC Tournament Committee**

5. **Substitutes:** OCUSBC assumes no responsibility to provide replacements. Replacements for the original entrants may be made providing the replacement meets eligibility and average requirements and must take the place in the line-up of the original entrant. Replacement must bowl under his/her own name.

6. **Tardy Players:** Bowlers arriving late shall begin play in frame being bowled. Missed frames shall be credited with a zero. Frames may not be made-up.
7. **Delay of Game:** If equipment failure on a pair of lanes would delay the progress of the series, a tournament official can authorize the completion of a game and series on another pair of certified lanes. The interrupted game and series must be resumed from the point of interruption. No practice will be allowed after being moved. See USBC Rule 321.
8. **Slow Bowling:** OCUSBC has allotted 3 hours. Except for those caused by lane breakdown (#7), no unreasonable delays will be permitted. Please be ready to bowl when it is your turn. Advise a scorekeeper if a bowler must leave the lanes, otherwise bowler may be given a zero for that frame and might be subject to disqualification. This will be determined at the discretion of the Tournament Director
9. **Re-Racks:** Each bowler is allowed a total of one re-rack per series. Additional re-racks may be granted by Tournament Director.
10. **Schedule Information:** Entries will be given preference in the order in which they are received
  - a. When all squads are filled, the next available date will be assigned.
  - b. Group reservations may be made, but FULL payment of entry fees MUST be submitted no later than two weeks after reservations are made or the spots will be forfeited.
  - c. The prize fund is returned 100% in a ratio of one prize for every eight entries.
11. **Bowling Attire:** All bowlers must wear suitable attire. No sexual, alcohol, tobacco or profane advertisements will be allowed on any attire or equipment. NO tanks tops, halter tops, sweats, spandex, "cut-offs" or short shorts, of any kind allowed. Walking shorts, "skorts" and skirts are permitted. Tournament Director shall determine the validity of any complaints.
12. **Disqualification:** While participating in scheduled events, a bowler may be disqualified immediately for the following:
  - a. An infraction of the rules
  - b. Delay in bowling
  - c. Unsportsmanlike behavior will not be tolerated on the lanes or inside the tournament venue. Individuals are subject to ejection for engaging in improper tactics or conduct including but not limited to physical and verbal abuse toward other persons.
  - d. Being under the influence of liquor or drugs
  - e. Use of a foreign substance(s)
  - f. Use of a false average
  - g. Failure to comply with the dress code
13. **Protest:** Any protest must be made in writing within 72 hours at the time of infraction to Tournament Director. See USBC Rule 329a (1).
14. **Entry Closing Date:** July 19, 2018 or when squads are filled. On site entries accepted.
15. **Tie Score:** In the event of a tie score in any division co-champions will be declared.
