1. **FEES:** Remit ONE personal check, or certified check for the total fees. Make payable to OCUSBC. Fees must be remitted to cover the events listed. Entry fee is \$35.00 per bowler, per event.
There will a \$25.00 fee for returned checks.
Prize Fund \$18.00 Expenses \$4.75 Linage \$12.75
Credit cards are now accepted by calling the OCUSBC office (714) 554-0111.
 2. **OPTIONAL ALL EVENTS:** The Fee is \$10.00 for this event to be paid with tournament entry fees.
 3. **OPTIONAL SCRATCH EVENT:** We are offering the following scratch events:
Team Event Fee \$40.00 (\$10 per person); Doubles \$20.00 (\$10.00 per person); Singles \$10.00;
All Events \$5.00. 100% returned as prize fund.
 4. **ELIGIBILITY:** Each entrant **MUST** be a member of the OUSBC with an average (see #5) bowled in an OCUSBC certified league.
 - a. Bowlers will be allowed to enter multiple times in team, doubles and singles events.
 - b. Bowlers who bowl multiple times with the same team members or doubles partner may only cash once in that event.
 - c. Bowlers bowling in multiple singles events may only cash once in that event.
 - d. Bowler entering doubles must also enter singles and vice-versa.
 - e. All Event scores are based upon bowler's initial entry into the tournament.
 - f. **Not more than TWO (2) PBA/PWBA professional bowlers are permitted in a team line up.**
 - g. **Only One (1) PBA/PWBA professional bowler per doubles team permitted.**
 5. **AVERAGE:** Entering Average must be established in an Orange County certified league.
The highest of the following averages will be used in the following order:
 - a. **OCUSBC tournament composite based on last 27 Open tournament games or OCUSBC winter/summer average from 2018-19 season with a minimum of 18 games.**
 - b. **Current Winter 2019-20 season OCUSBC league average with a minimum of 18 games. League sheet must accompany entry.**
 - c. **If none of the above, the bowler will enter at 230.**
- Note:**
- USBC Rule 319a conditions that apply
 - USBC Rule 319b Assigned Average
 - USBC Rule 319c (rerating) will be enforced as necessary
 - USBC Rule 319d and 319e will be waived
 - USBC Rule 319a three (3) will be enforced (Failure to report average)
 - USBC 201 applies (sport average adjustment) and will be enforced as necessary, Any bowler who bowls in a 'Challenge' league, or any other known league that bowls on a sport condition, which does not certify with USBC as a sport league, will be subject to re-rating by the Tournament Director as deemed necessary by the OCUSBC Tournament Committee
6. **HANDICAP:** Bowlers will receive 90% of 230 for each event, including All Events.
 7. **SUBSTITUTES:** OCUSBC assumes no responsibility to provide replacements. Replacements for the original entrants may be made providing the replacement meets eligibility and average requirements and must take the place in the line-up of the original entrant. Replacement must bowl under his/her own name.
 8. **TARDY BOWLERS:** Bowlers arriving late shall begin play in the frame being bowled. Missed frames will be credited with a zero. Frames may not be made-up.
 9. **DELAY OF GAME:** If equipment failure on a pair on lanes would delay the progress of the series, a tournament official can authorize the completion of a game and series on another pair of certified lanes. The interrupted game and series must be resumed from the point of interruption. No practice will be allowed after being moved. See USBC Rule #321.
 10. **SLOW BOWLING:** OCUSBC has allotted three (3) hours for team event and doubles/singles events to be completed. Except for those delays caused by lane breakdown (#9), no unreasonable delays will be permitted. Please be ready to bowl when it is your turn. Advise a scorekeeper if a bowler must leave the lanes, otherwise bowlers may be given a zero for that frame and might be subject to disqualification. This will be determined at the discretion of the Tournament Director.
 11. **RE-RACKS:** Each bowler is allowed a total of one re-rack per series. Additional re-racks may be granted by Tournament Director.

12. **SCHEDULE INFORMATION:** Entries will be given preference in the order in which they are received.
 - a. When all squads are filled the next available date will be assigned.
 - b. Teams wishing to bowl together must submit entries together.
 - c. Group reservation maybe made. Full payment of entry fees **MUST** be submitted no later than two (2) weeks after the reservations are made or the spot(s) will be forfeited.
 - d. Bowlers will bowl doubles first. If one bowler is late for the doubles event the entrant present will bowl singles event first.
 - e. In the event of a tie for 1st place co-champions will be declared.
 - f. The prize fund is returned 100% in a ratio of one (1) prize for every eight (8) entries.
13. **BOWLING ATTIRE:** All bowlers must ware suitable attire. No sexual, alcohol, tobacco or profane advertisement will be allowed on any attire or equipment. No Tank Tops, Hater Tops, Sweats, Spandex, cut-off's or Short-Shorts, of any kind will be allowed. Walking Shorts, "skorts" and skirts are permitted.
14. **DISQUALIFICATION:** While participating in scheduled events, a bowler may be disqualified immediately for the following:
 1. An infraction of the rules.
 2. Delay in bowling.
 3. Unsportsmanlike behavior will not be tolerated on the lanes or inside the tournament venue. Individuals are subject to ejection for engaging in improper tactics or conduct, including but not limited to, physical and verbal abuse towards other persons.
 4. Being under the influence of liquor or drugs.
 5. Use of a foreign substance(s).
 6. Use of false average.
 7. Failure to comply with the dress code.
15. **PROTEST:** Any protest must be made in **writing within 72 hours at the time of infraction** to Tournament Director:
